I recognize and acknowledge that there are certain risks of physical injury to participants in Marengo-Union Girls Softball Association program(s) and I agree to assume the full risk of any injuries, including death, damages or loss regardless of severity which I or my minor child/ward may sustain as a result of participating in any and all activities connected with such program(s).

I agree to waive and relinquish all claims I or my minor child/ward may have as a result of participation in the program against Marengo-Union Girls Softball Association and its officers, agents, servants, and employees.

I do hereby fully release and discharge the Marengo-Union Girls Softball Association and its officers, agents, servants, and employees from any and all claims from injuries including death, damages, and losses sustained by me or my minor child/ward arising out of, connected with, or in any way associated with the activities of the program(s)

I further agree to indemnify and defend the Marengo-Union Girls Softball Association and its officers, agents, servants, and employees from any and all claims resulting from injuries including, death, damages, and losses sustained by me or my minor child/ward arising out of, connected with, or in any way associated with the activities of the programs(s).

In the event of any emergency, I authorize Marengo-Union Girls Softball Association officials to secure from any licensed hospital, physician and/or medical personnel any treatment deemed necessary for me or my minor child/ward's immediate care and agree that I will be responsible for payment of any and all medical services rendered.

ZERO TOLERANCE GUIDELINES AND AGREEMENT

The Marengo-Union Girls Softball is in complete support of the Zero Tolerance Guidelines adopted by the Board of Directors and Officers of Marengo-Union Girls Softball Association regarding personal conduct.

The negative conduct of spectators, players, coaches and affiliates representing the League or its Members will not be tolerated. The negative conduct of just a few individuals can ruin the girls softball experience for all that are exposed to it and destroy the reputation of this organization.

Situations that arise from, but not limited to, the verbal and/or physical abuse of officials, players, coaches and spectators will be dealt with in a most serious matter by the Board of Directors and Officers of the Marengo-Union Girls Softball Association and will not result in any opportunity for financial loss recovery by affected individuals.
